

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0687

Affirmed

*Late Request for Hearing on Decision # 155137 Allowed, Overpayment Assessed
Waivers of PEUC and FPUC Overpayments Granted*

PROCEDURAL HISTORY: On August 2, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received \$6,120 in regular unemployment insurance (regular UI), \$7,752 in Pandemic Emergency Unemployment Compensation (PEUC), and \$10,200 in Federal Pandemic Unemployment Compensation (FPUC) benefits to which she was not entitled and must repay (decision # 155137). On August 22, 2022, decision # 155137 became final without claimant filing a request for hearing. On March 17, 2023, the Department served notice of an administrative decision denying claimant's request for a waiver of the remaining overpayment balances of \$3,855 for the PEUC overpayment previously assessed and \$10,710 for the FPUC overpayment previously assessed (decision # 143913). On March 22, 2023, claimant filed a late request for hearing on decision # 155137 and a timely request for hearing on decision # 143913.

On May 31, 2023, ALJ Mott conducted separate hearings regarding decisions # 155137 and 143913. On June 2, 2023 ALJ Mott issued Order No. 23-UI-226781, allowing claimant's late request for hearing on decision # 155137 and modifying that decision by concluding that claimant was liable for overpayments of \$6,120 in regular UI benefits, \$7,752 in PEUC benefits, and \$10,200 in FPUC benefits to be deducted from future benefits payable. Also on June 2, 2023, ALJ Mott issued Order No. 23-UI-226785, reversing decision # 143913, by concluding that claimant's for a waiver of her PEUC and FPUC overpayments request should be granted. On June 16, 2023, the Department filed applications for review of Orders No. 23-UI-226781 and 23-UI-226785 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-226781 and 23-UI-226785. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-0686 and 2023-EAB-0687).

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 23-UI-226781 and 23-UI-226785 are affirmed.
