

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0690

Affirmed
Disqualification

PROCEDURAL HISTORY: On March 17, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and therefore was disqualified from receiving unemployment insurance benefits effective July 31, 2022 (decision # 84911). Claimant filed a timely request for hearing. On May 23, 2023, ALJ Lucas conducted a hearing, and on May 31, 2023 issued Order No. 23-UI-226464, modifying decision # 84911 by concluding that claimant was disqualified from receiving benefits effective August 7, 2022.¹ On June 19, 2023, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant submitted written arguments on June 19, 2023 and June 20, 2023. Claimant did not declare that she provided a copy of either argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The arguments also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-226464 is affirmed.
