EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0698

Late Application for Review Dismissed

PROCEDURAL HISTORY: On April 5, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain benefits, and assessing an overpayment of \$12,220 in regular unemployment insurance (regular UI) and \$13,500 in Federal Pandemic Unemployment Compensation (FPUC) benefits that claimant was required to repay, a \$7,716 monetary penalty, and a 52-week penalty disqualification from future benefits (decision # 195449). On April 25, 2022, decision # 195449 became final without claimant having filed a request for hearing. On June 28, 2022, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on October 13, 2022 issued Order No. 22-UI-205077, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by October 27, 2022. On October 25, 2022, claimant filed a timely response to the appellant questionnaire.

On March 2, 2023, the Office of Administrative Hearings (OAH) mailed a letter to claimant stating that Order No. 22-UI-0205077 was vacated and a hearing would be scheduled to determine whether to allow claimant's late request for hearing and, if so, the merits of decision # 195449. On March 29, 2023, ALJ Blam conducted the hearing, and on April 6, 2023 issued Order No. 23-UI-221229, dismissing claimant's request for hearing as late without good cause and leaving decision # 195449 undisturbed. On April 26, 2023, Order No. 23-UI-221229 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On June 20, 2023, claimant filed a late application for review of Order No. 23-UI-221229 with EAB.

FINDING OF FACT: (1) Order No. 23-UI-221229, mailed to claimant on April 6, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-221229 at 4. Order No. 23-UI-221229 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before April 26, 2023 to be timely."

CONCLUSION AND REASONS: Claimant's late application for review is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-221229 was due April 26, 2023. Because claimant did not file his application for review until June 20, 2023, the application for review was late. Claimant's application for review did not include a written statement explaining why claimant did not file the application for review by the April 26, 2023 deadline. Accordingly, claimant did not show good cause for the late application for review, and their late application for review is dismissed.

DECISION: The application for review filed June 20, 2023 is dismissed. Order No. 23-UI-221229 remains undisturbed.
