EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0699

Late Application for Review Dismissed

PROCEDURAL HISTORY: On August 13, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and was ineligible for benefits for the week of July 25 through 31, 2021 (week 30-21) and until the reason for the denial had ended. On September 2, 2021, the August 13, 2021 administrative decision became final without claimant having filed a request for hearing. On October 6, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on December 28, 2021 issued Order No. 21-UI-182797, the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by January 11, 2022. On January 11, 2022, claimant filed a timely response to the appellant questionnaire.

On March 29, 2022, the Office of Administrative Hearings (OAH) mailed a letter to claimant stating that Order No. 21-UI-182797 was vacated and a hearing would be scheduled to determine whether to allow claimant's late request for hearing and, if so, the merits of the August 13, 2021 administrative decision. On December 15, 2022 OAH served notice that the hearing was scheduled for December 29, 2022. On December 29, 2022, claimant failed to appear at the hearing, and on December 30, 2022 ALJ Mott issued Order No. 22-UI-211340, dismissing claimant's late request for hearing due to her failure to appear.

On January 18, 2023, claimant filed a timely request to reopen the December 29, 2022 hearing. On May 2, 2023, OAH served notice of a hearing scheduled for May 16, 2023 to determine whether to grant claimant's request to reopen and claimant's late request for hearing, and if so, the merits of the August 13, 2021 administrative decision. On May 16, 2023, ALJ Frank conducted the hearing, and on May 24, 2023 issued Order No. 23-UI-226000, allowing claimant's request to reopen the December 29, 2022 hearing but re-dismissing claimant's request for hearing as late without good cause, leaving the August 13, 2021 administrative decision undisturbed. On June 13, 2023, Order No. 23-UI-226000 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On June 20, 2023, claimant filed a late application for review of Order No. 23-UI-226000 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's attachments to the

application for review, marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 23-UI-226000, mailed to claimant on May 24, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-226000 at 5. Order No. 23-UI-226000 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before June 13, 2023 to be timely."

CONCLUSION AND REASONS: Claimant's late application for review is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-226000 was due June 13, 2023. Because claimant did not file her application for review until June 20, 2023, the application for review was late. With her application for review, claimant provided copies of train and airline itineraries, suggesting that claimant may have embarked on international travel immediately following the May 16, 2023 hearing. EAB Exhibit 1 at 1-5. However, claimant did not submit a statement explaining the significance of these documents or describing circumstances that prevented claimant from filing the application for review on time, as required under OAR 471-041-0070(3). Because claimant's application for review did not contain a written statement describing the circumstances that prevented a timely filing, her late application for review is dismissed.

DECISION: The application for review filed June 20, 2023 is dismissed. Order No. 23-UI-226000 remains undisturbed.
