

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0700

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On February 10, 2021, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was ineligible for PUA benefits effective February 2, 2020. On March 2, 2021, the February 10, 2021 PUA determination became final without claimant having filed a request for hearing. On September 13, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on October 28, 2021 issued Order No. 21-UI-178428, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by November 11, 2021. On November 9, 2021, claimant filed a timely response to the appellant questionnaire.

On February 17, 2022, the Office of Administrative Hearings (OAH) mailed a letter to claimant stating that Order No. 21-UI-178428 was vacated and that a hearing would be scheduled to determine whether to allow claimant's late request for hearing and, if so, the merits of the February 10, 2021 PUA determination. On April 6, 2023, OAH served notice that the hearing was scheduled for April 20, 2023. On April 20, 2023, claimant failed to appear at the hearing, and ALJ Lucas issued Order No. 23-UI-222779, dismissing claimant's late request for hearing due to their failure to appear. On May 4, 2023, claimant filed a timely request to reopen the hearing. ALJ Kangas considered claimant's request, and on May 31, 2023 issued Order No. 23-UI-226474, denying the request and leaving Order No. 23-UI-222779 undisturbed. On June 20, 2023, claimant filed an application for review of Order No. 23-UI-226474 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered claimant's argument in reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-226474 is affirmed.
