

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0701

Affirmed
Overpayment, No Penalties

PROCEDURAL HISTORY: On December 29, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain benefits, and assessing an overpayment of \$9,225.00 in regular unemployment insurance (regular UI) and \$6,600.00 in Federal Pandemic Unemployment Compensation (FPUC) benefits that claimant was required to repay, a \$2,373.75 monetary penalty, and a 52-week penalty disqualification from future benefits (decision # 193309). Claimant filed a timely request for hearing. On May 30, 2023, ALJ Goodrich conducted a hearing at which the employer failed to appear, and on June 7, 2023 issued Order No. 23-UI-227186, modifying decision # 193309 by assessing an overpayment of \$9,225.00 in regular UI and \$6,600.00 in FPUC benefits that claimant was required to repay, and concluding that claimant did not willfully make a misrepresentation or fail to report a material fact to obtain benefits and therefore was not liable for a monetary penalty or penalty disqualification. On June 20, 2023, the employer filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-227186 is affirmed.
