EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0703

Late Application for Review Dismissed

PROCEDURAL HISTORY: On February 14, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective December 18, 2022 (decision # 124356). Claimant filed a timely request for hearing. On April 25, 2023, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for May 11, 2023. On May 11, 2023, claimant failed to appear at the hearing, and on May 12, 2023 ALJ Messecar issued Order No. 23-UI-224728, dismissing claimant's request for hearing due to claimant's failure to appear.

On May 18, 2023, claimant filed a timely request to reopen the hearing. ALJ Kangas considered claimant's request, and on May 30, 2023 issued Order No. 23-UI-226379, dismissing the request and leaving Order No. 23-UI-224728 undisturbed. On June 20, 2023, Order No. No. 23-UI-226379 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On June 21, 2023, claimant filed a late application for review of Order No. No. 23-UI-226379 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's written statement enclosed with the application for review and the postmarked date on the application for review. This evidence has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. No. 23-UI-226379, mailed to claimant on May 30, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. No. 23-UI-226379 at 3. Order No. 23-UI-226379 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before June 20, 2023 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 23-UI-226379 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-226379 was due by June 20, 2023. Because claimant did not file their application for review until June 21, 2023, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe circumstances preventing them from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed June 21, 2023 is dismissed. Order No. 23-UI-226379 remains undisturbed.
