# EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0712

Affirmed Request to Reopen Denied

**PROCEDURAL HISTORY:** On December 5, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged by the employer for misconduct and disqualified from receiving benefits effective November 13, 2022 (decision # 95855). Claimant filed a timely request for hearing. On January 17, 2023, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for January 31, 2023. On January 31, 2023, claimant failed to appear at the hearing, and ALJ Zeitner issued Order No. 23-UI-214303, dismissing claimant's request for hearing due to his failure to appear, leaving decision # 95855 undisturbed.

On February 8, 2023, claimant filed a timely request to reopen the January 31, 2023 hearing. On March 20, 2023, OAH mailed a letter stating that Order No. 23-UI-214303 was vacated and that a new hearing would be scheduled to determine whether to allow claimant's request for a reopening and, if so, the merits of decision # 95855. On March 21, 2023, OAH served notice that the hearing was scheduled for March 30, 2023. On March 30, 2023, claimant failed to appear at the hearing, and ALJ S. Lee issued Order No. 23-UI-220628, dismissing claimant's request for a reopening due to his failure to appear, leaving Order No. 23-UI-214303 undisturbed.

On April 13, 2023, claimant filed a timely request to reopen the March 30, 2023 hearing. On May 18, 2023, OAH mailed a letter stating that Order No. 23-UI-220628 was vacated and that a new hearing would be scheduled to determine whether to allow claimant's request to reopen the March 30, 2023 hearing, if so, whether to allow claimant's request to reopen the January 31, 2023 hearing, and if so, the merits of decision # 95855. On June 5, 2023, ALJ Goodrich conducted the hearing, and on June 6, 2023

issued Order No. 23-UI-226983, denying claimant's request to reopen the March 30, 2023 hearing and leaving Order No. 23-UI-220628 undisturbed. On June 26, 2023, claimant filed an application for review of Order No. 23-UI-226983 with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** Claimant did not declare that he provided a copy of his argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented him from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 23-UI-226983 is affirmed.
