

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0718

Affirmed
Ineligible Weeks 11-23 through 13-23
Eligible Weeks 14-23 through 15-23

PROCEDURAL HISTORY: On March 30, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and was ineligible for benefits for the week of March 12 through 18, 2023 (week 11-23) and until the reason for the denial had ended. Claimant filed a timely request for hearing. On June 22, 2023, ALJ Murray-Roberts conducted a hearing and issued Order No. 23-UI-228449, modifying the March 30, 2023 administrative decision by concluding that claimant was ineligible for benefits from March 12 through April 1, 2023 (weeks 11-23 through 13-23), but was eligible for benefits from April 2 through 15, 2023 (weeks 14-23 through 15-23). On June 27, 2023, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's argument to the extent it was based on the record.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-228449 is affirmed.
