EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0732

Late Application for Review Dismissed

PROCEDURAL HISTORY: On February 21, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged, but not for misconduct, and was therefore not disqualified from receiving unemployment insurance benefits based on the work separation (decision # 145151). The employer filed a timely request for hearing. On March 20, 2019, notice was mailed to the parties that a hearing was scheduled for April 3, 2019. On April 3, 2019, ALJ Wyatt conducted a hearing at which claimant failed to appear, and on April 11, 2019 issued Order No. 19-UI-127979, reversing decision # 145151 by concluding that claimant was discharged for misconduct and was disqualified from receiving benefits effective January 20, 2019. On April 25, 2019, claimant filed a timely request to reopen the April 3, 2019 hearing. ALJ Kangas considered claimant's request, and on May 1, 2019 issued Order No. 19-UI-129127, denying claimant's request to reopen and leaving Order No. 19-UI-127979 undisturbed. On May 21, 2019, Order No. 19-UI-129127 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On June 30, 2023, claimant filed a late application for review of Order No. 19-UI-129127 with EAB.

FINDING OF FACT: (1) Order No. 19-UI-129127, mailed to claimant on May 1, 2019, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 19-UI-129127 at 3. Order No. 19-UI-129127 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before May 21, 2019 to be timely."

CONCLUSION AND REASONS: Claimant's late application for review is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing

ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 19-UI-129127 was due May 21, 2019. Because claimant did not file their application for review until June 30, 2023, the application for review was late. Claimant's application for review did not include a written statement explaining why claimant did not file the application for review by the May 21, 2019 deadline. Accordingly, claimant did not show good cause for the late application for review, and their late application for review is dismissed.

DECISION: The application for review filed June 30, 2023 is dismissed.
