EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0737

Late Application for Review Dismissed Without Prejudice

PROCEDURAL HISTORY AND FINDINGS OF FACT: On December 12, 2022, the Oregon Employment Department (the Department) served notice of a wage and potential benefit report (WPBR) concluding that claimant did not have sufficient earnings to establish a monetarily valid claim for unemployment insurance benefits. On December 22, 2022, the December 12, 2022 WPBR became final without claimant having filed a request for hearing. On March 6, 2023, claimant filed a late request for hearing on the December 12, 2022 WPBR. ALJ Kangas considered claimant's request, and on June 8, 2023 issued Order No. 23-UI-227265, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by June 22, 2023. On June 28, 2023, Order No. 23-UI-227265 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On July 3, 2023, claimant filed a late application for review of Order No. 23-UI-227265 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement claimant provided with their late application for review, which is also claimant's response to the appellant questionnaire attached to Order No. 23-UI-227265, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

CONCLUSION AND REASONS: Claimant's late application for review is dismissed without prejudice.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing

ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-227265 was due June 28, 2023. Because claimant did not file their application for review until July 3, 2023, the application for review was late. Claimant provided a written statement with their application for review, which was a response to the appellant questionnaire attached to Order No. 23-UI-227265. However, the written statement did not describe the circumstances that prevented claimant from filing the application for review on time, as required under OAR 471-041-0070(3). Claimant's late application for review is therefore subject to dismissal.

However, in claimant's appellant questionnaire response, claimant responded to a question by stating that they received the *administrative decision* on June 29, 2023. EAB Exhibit 1 at 1. As claimant filed their hearing request on that administrative decision – the December 12, 2022 WPBR – on March 6, 2023, claimant's answer suggests that they may have been referring to receiving Order No. 23-UI-227265 on June 29, 2023 instead of the December 12, 2022 WPBR. If claimant received Order No. 23-UI-227265 after the June 28, 2023 deadline, this may have constituted a circumstance beyond claimant's reasonable control that prevented timely filing of their application for review. It is therefore possible that claimant could show good cause to extend the deadline for timely filing.

The deadline for filing an application for review may be extended a reasonable time upon a showing of good cause. *See* ORS 657.875; OAR 471-041-0070. If the appellant believes they have good cause and filed their late application for review within a reasonable time, the appellant may request that EAB reconsider this decision under OAR 471-041-0145 (May 13, 2019).

EAB will dismiss any request for reconsideration that does not include all five of the following:

- 1. The appellant must file the request for reconsideration within 20 days of the date this decision was mailed; the date this decision was mailed is August 16, 2023, making the deadline September 5, 2023¹ to file the request for reconsideration, *and*
- 2. The appellant must include a statement on the request for reconsideration declaring that they sent a copy of the request to the other party, *and*
- 3. The appellant must provide additional specific details about the reason they filed a late application for review. For example, the appellant should include specific information about the date they received Order No. 23-UI-227265, whether they read it, whether they agreed or disagreed with Order No. 23-UI-227265, the reason(s) why they did not file the application for review before the deadline, how the reason(s) affected their ability to file a timely application for review, including the dates on which the appellant may have spoken to anyone at OAH or EAB regarding whether or not they could still appeal Order No. 23-UI-227265 and any other specific details that might help EAB determine whether or not the appellant had "good cause," which means factors or circumstances beyond their reasonable control prevented them from filing a timely application for review, *and*

¹ Parties only get 20 days to respond regardless of holidays or if the deadline falls on a weekend.

- 4. The appellant must provide the date the circumstances that prevented them from filing a timely application for review (which they listed in response to #3, above) ended, *and*
- 5. The appellant must provide sufficient information to prove that they filed their application for review within seven days of that date.

The appellant may file a request for reconsideration in many ways; please note that you need only file *one* request for reconsideration:

- 1. Use your smart phone, tablet, or computer to fill out the "File a Written Argument" form, available on EAB's website: https://www.oregon.gov/EMPLOY/EAB/Pages/default.aspx, or
- 2. Use your smart phone, tablet, or computer to send an email to EAB at OED_EAB_OFFICE@employ.oregon.gov, *or*
- 3. Send the request by U.S. mail or another delivery service, addressed to 875 Union St NE, Salem, Oregon 97311, *or*
- 4. Send EAB a fax at 503-378-2129.

DECISION: The application for review filed July 3, 2023 is dismissed without prejudice. Order No. 23-UI-227265 remains undisturbed.
