

**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-0738**

*Affirmed*  
*Late Request for Hearing Dismissed*

**PROCEDURAL HISTORY:** On June 8, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received benefits to which they were not entitled, and assessing an overpayment of \$1,884 in regular unemployment insurance (regular UI) benefits and \$2,100 in Federal Pandemic Unemployment Compensation (FPUC) benefits that claimant was liable to repay to the Department (decision # 164833). On June 28, 2022, decision # 164833 became final without claimant having filed a request for hearing. On January 10, 2023, claimant filed a late request for hearing on decision # 164833. ALJ Kangas considered claimant's request, and on May 18, 2023 issued Order No. 23-UI-225346, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by June 1, 2023. On June 7, 2023, claimant filed a late response to the appellant questionnaire and a timely application for review with the Employment Appeals Board (EAB). On July 3, 2023, ALJ Kangas mailed a letter to claimant stating that because the appellant questionnaire response was late, it would not be considered and a new decision would not be issued. This matter comes before EAB based upon claimant's June 7, 2023 application for review.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the appellant questionnaire response claimant included with their application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**FINDINGS OF FACT:** (1) On June 8, 2022, the Department mailed decision # 164833 to claimant's address of record on file with the Department.

(2) At the time that decision # 164833 was mailed, claimant was not claiming benefits and did not have a pending appeal. Claimant no longer lived at the address to which decision # 164833 was mailed.

However, it was forwarded to claimant's current address by the Postal Service, and claimant eventually received it. Claimant did not immediately open the envelope.

(3) In January 2023, claimant opened decision # 164833. On January 10, 2023, claimant filed a request for hearing on decision # 164833.

**CONCLUSIONS AND REASONS:** Claimant's late request for hearing is dismissed.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist. Good cause does not include failure to receive a document due to not notifying the Employment Department or Office of Administrative Hearings of an updated address while the person is claiming benefits or if the person knows, or reasonably should know, of a pending appeal. OAR 471-040-0010(1)(b)(A).

The deadline to file a timely request for hearing on decision # 164833 was June 28, 2022. Claimant filed their request for hearing on January 10, 2023. Accordingly, the request for hearing was late.

Claimant initially failed to receive decision # 164833 because claimant moved and failed to update their address with the Department. However, as claimant was not claiming benefits or pursuing an appeal at the time, this constituted a factor beyond claimant's reasonable control that may have prevented claimant from timely filing a request for hearing. This factor ceased when claimant received decision # 164833 after it was forwarded to their new address. Claimant wrote that they "didn't think to open [the envelope containing decision # 164833] right away" and "didn't open it until January [2023]." EAB Exhibit 1 at 1-2. It can be inferred from these statements that claimant received decision # 164833 sometime prior to January 2023. The record therefore shows that claimant more likely than not received decision # 164833 no later than December 31, 2022 and the factor beyond claimant's reasonable control that prevented timely filing therefore ceased prior to January 1, 2023. As claimant filed their late request for hearing on January 10, 2023, claimant did not file their request within a seven-day "reasonable time" after the factor that prevented timely filing ceased. Accordingly, claimant has not shown good cause to extend the deadline for timely filing to January 10, 2023, and claimant's late request for hearing is dismissed.

**DECISION:** Order No. 23-UI-225346 is affirmed.
