

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0743

Affirmed
Ineligible Weeks 16-23 through 24-23

PROCEDURAL HISTORY: On May 8, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not able to work, available to work, or actively seeking work during the weeks including April 16, 2023 through April 29, 2023 (weeks 16-23 through 17-23) and was therefore denied unemployment insurance benefits during those weeks and until the reason for the denial had ended (decision # 140715). Claimant filed a timely request for hearing. On June 21, 2023, ALJ Adamson conducted a hearing, and on June 28, 2023 issued Order No. 23-UI-228890, modifying decision # 140715¹ by concluding claimant was not able to work or actively seeking work during the weeks including April 16, 2023 through June 17, 2023 (weeks 16-23 through 24-23) and was therefore denied benefits for those weeks. On July 5, 2023, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-228890 is affirmed.
