

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0753

Late Application for Review Dismissed

PROCEDURAL HISTORY: On July 15, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to provide information in accordance with the Department's rules and therefore was ineligible to receive benefits for the weeks including June 19, 2022 through July 2, 2022 (weeks 25-22 through 26-22) and until the reason for the denial had ended (decision # 595473). On August 4, 2022, decision # 595473 became final without claimant having filed a request for hearing. On September 21, 2022, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on January 17, 2023, issued Order No. 23-UI-212725, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by January 31, 2023. On February 6, 2023, Order No. 23-UI-212725 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On July 6, 2023, claimant filed a late application for review of Order No. 23-UI-212725 with EAB. This matter comes before EAB based upon claimant's late application for review of Order No. 23-UI-212725.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement included with claimant's late application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

FINDING OF FACT: (1) Order No. 23-UI-212725, mailed to claimant on January 17, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-212725 at 2. Order No. 23-UI-212725 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than February 6, 2023."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 23-UI-212725 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-212725 was due by February 6, 2023. Because claimant did not file their application for review until July 6, 2023, the application for review was late. Claimant provided a written statement with the application for review. However, claimant’s written statement did not describe circumstances preventing them from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant’s late application for review is dismissed.

DECISION: The application for review filed July 6, 2023 is dismissed. Order No. 23-UI-212725 remains undisturbed.
