

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0755

Affirmed
Overpayment and Penalties

PROCEDURAL HISTORY: On April 3, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain benefits, assessing a \$16,034 overpayment that claimant was required to repay to the Department, a \$4,810.20 monetary penalty, and a 52 week penalty disqualification from future benefits (decision # 201703). Claimant filed a timely request for hearing. On May 24, 2023, a hearing was held by ALJ Fraser. The hearing was continued on June 8, 2023 by ALJ Mott, at which the claimant and the employer appeared. The hearing was continued to June 15, 2023, at which claimant did not appear. On July 10, 2023, ALJ Mott issued Amended Final Order No. 23-UI-229933¹, modifying decision # 201703 by concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain benefits, assessing a \$14,834 overpayment that claimant is required to repay to the Department, a \$4,810.20 monetary penalty, and a 52-week penalty disqualification from future benefits. On July 6, 2023, claimant filed an application for review with the Employment Appeals Board (EAB).²

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-229933 is affirmed.
