

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0762

Affirmed
No Disqualification

PROCEDURAL HISTORY: On May 8, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged for misconduct and was therefore disqualified from receiving unemployment insurance benefits effective April 16, 2023 (decision # 94815). Claimant filed a timely request for hearing. On June 20, 2023, ALJ Taylor conducted a hearing, and on June 28, 2023 issued Order No. 23-UI-228879, reversing decision # 94815 by concluding that claimant was discharged, but not for misconduct, and was not disqualified from receiving benefits based on the work separation. On July 10, 2023, the employer filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB did not consider claimant's written argument when reaching this decision because she did not include a statement declaring that she provided a copy of the argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). EAB considered the employer's written argument in reaching this decision.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The employer asserted that they served the additional evidence on claimant in advance of the hearing and suggested that they had also submitted the evidence to the Office of Administrative Hearings (OAH) before the hearing but was unaware that the ALJ had not received it. Employer's Written Argument at 2. This constituted a factor or circumstance beyond the employer's reasonable control that prevented the employer from offering the additional evidence into the hearing record. The additional evidence is an investigative summary and claimant's training record consisting of 11 pages attached to the employer's written argument. This evidence is relevant and material to EAB's decision. Accordingly, this additional evidence has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-228879 is affirmed.
