EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0768

Order No. 23-UI-229142 Affirmed – Late Request for Hearing Dismissed,
Decision # 94055 Undisturbed
Order No. 23-UI-229141 Affirmed – Waiver of FPUC Overpayment Denied

PROCEDURAL HISTORY: On November 9, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to disclose a material fact and was overpaid \$1,963 in regular unemployment insurance (regular UI) and \$3,900 in Federal Pandemic Unemployment Compensation (FPUC) benefits that claimant must repay to the Department (decision # 94055). On November 29, 2021, decision # 94055 became final without claimant having filed a request for hearing. On February 22, 2022, the Department served notice of an administrative decision denying claimant's request for a waiver of the \$3,900 FPUC overpayment that the Department had assessed in decision # 94055 (decision # 150115). On March 11, 2022, claimant filed a late request for hearing on decision # 94055 and a timely request for hearing on decision # 150115.

On February 28, 2023, ALJ Blam conducted a hearing, and on March 15, 2023 issued Order No. 23-UI-219033, dismissing claimant's request for hearing on decision # 94055 as late without good cause and leaving decision # 94055 undisturbed; and Order No. 23-UI-219031, affirming decision # 150115 on the merits. On March 20, 2023, claimant filed applications for review of Orders No. 23-UI-219033 and 23-UI-219031 with the Employment Appeals Board (EAB). On May 5, 2023, EAB issued EAB Decisions 2023-EAB-0417 and 2023-EAB-0416, which reversed Orders No. 23-UI-219033 and 23-UI-219031 and remanded the matters for further development of the record. On May 31, 2023, ALJ Blam conducted a consolidated hearing on remand, and on June 29, 2023 issued Order No. 23-UI-229142, re-dismissing claimant's request for hearing on decision # 94055 as late without good cause and leaving decision # 94055 undisturbed; and Order No. 23-UI-229141, re-affirming decision # 150115 on the merits. On July 10, 2023, claimant filed applications for review of Orders No. 23-UI-229142 and 23-UI-229141 with EAB.

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090

(May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's argument to the extent it was based on the record.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-229142 and 23-UI-229141. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-0768 and 2023-EAB-0769).

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

Claimant is reminded that she remains free to submit an application for waiver of recovery of her regular unemployment insurance overpayment. Additional details for doing so are included in the note below.

DECISION: Orders No. 23-UI-229142 and 23-UI-229141 are affirmed.
