

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0771

Affirmed
Ineligible Weeks 08-23 through 24-23

PROCEDURAL HISTORY: On March 17, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision, replacing decision # 85534 issued on March 13, 2023, by concluding that claimant was not able to work the weeks of February 19, 2023 through March 11, 2023 and was therefore ineligible to receive unemployment insurance benefits during those weeks and until the reason for the denial had ended (decision # 70403). Claimant filed a timely request for hearing. On June 21, 2023, ALJ Frank conducted a hearing interpreted in Bosnian, and on June 28, 2023 issued Order No. 23-UI-229019, modifying decision # 70403 by concluding that claimant was not able to work for the weeks of February 19, 2023 through June 17, 2023 (weeks 08-23 through 24-23) and was therefore ineligible to receive benefits for those weeks. On July 11, 2023, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-229019 is affirmed.
