

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0773

Affirmed
No Disqualification

PROCEDURAL HISTORY: On August 18, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was disqualified from receiving unemployment insurance benefits effective March 7, 2021 (decision # 111737). On September 7, 2021, decision # 111737 became final without claimant having filed a request for hearing. On April 4, 2023, claimant filed a late request for hearing. On June 14, 2023, ALJ Adamson conducted a hearing, and on June 22, 2023 issued Order No. 23-UI-228450, allowing claimant's late request for hearing and reversing decision # 111737 by concluding that claimant was discharged, but not for misconduct, and was not disqualified from receiving benefits based on the work separation. On July 11, 2023, the employer filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: On August 20, 2023, the employer sent EAB an email advising that they had just mailed a written argument to EAB in this matter. That written argument has not been received as of the date of this decision.

If and when the employer's written argument is ultimately received, EAB would not be permitted to consider it because it was not received by EAB within the time period allowed under OAR 471-041-0080(1) (May 13, 2019). *See* OAR 471-041-0080(2)(b). Under OAR 471-041-0080(1), the employer was required to submit a written argument within 20 days of the date that EAB provided notice of receipt of the employer's application for review. EAB provided the employer notice of receipt of the employer's application for review by mail on July 24, 2023, meaning the deadline to submit a written argument was August 14, 2023.¹ Moreover, although EAB has discretion to extend the deadline to file an argument, it may not do so in this case beyond August 15, 2023. That is because, given that the employer's application for review was filed on July 11, 2023, to extend the deadline to file beyond August 15, 2023 would mean the total period allowed for written argument, including all extensions,

¹ Twenty days after July 24, 2023 was August 13, 2023. However, as August 13, 2023 was a Sunday, the deadline extended one day to August 14, 2023. *See* ORS 187.010(1)(a) and (3).

would exceed 35 days from the application for review filing date, which is not permitted under OAR 471-041-0080(4)(a)(E).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-228450 is affirmed.
