# EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0780

Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On May 4, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and was ineligible for benefits for the week of April 16 through 22, 2023 (week 16-23) and until the reason for the denial ended. Claimant filed a timely request for hearing. On June 15, 2023, ALJ Nyberg conducted a hearing, and on June 23, 2023 issued Order No. 23-UI-228556, modifying the May 4, 2023 administrative decision by concluding that claimant failed to register for work and was ineligible for benefits from April 16 through 22, 2023 and May 7 through June 3, 2023 (weeks 16-23 and 19-23 through 22-23). Claimant filed an application for review with the Employment Appeals Board (EAB).

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's application for review and the postmarked envelope containing claimant's application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**FINDINGS OF FACT:** (1) Order No. 23-UI-228556, mailed to claimant on June 23, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-228556 at 5. Order No. 23-UI-228556 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before July 13, 2023 to be timely."

(2) Claimant filed their application for review of Order No. 23-UI-228556 by mail. The postmark date affixed to the envelope in which the application for review was mailed is July 14, 2023.

**CONCLUSIONS AND REASONS:** Claimant's application for review of Order No. 23-UI-228556 is dismissed as late without a showing of good cause.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The filing date for an application for review filed by mail is the postmark date affixed to the envelope in which the application was mailed. OAR 471-041-0065(1)(b) (May 13, 2019). The postmark date on the envelope in which claimant mailed their application for review was July 14, 2023. EAB Exhibit 1 at 2. July 14, 2023 therefore is the filing date. The application for review of Order No. 23-UI-228556 was due July 13, 2023. Because claimant did not file their application for review until July 14, 2023, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented claimant from filing the application for review by the July 13, 2023 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed July 14, 2023 is dismissed. Order No. 23-UI-228556 remains undisturbed.
