# EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0784

Affirmed
Request to Reopen Allowed
Request for Hearing Timely
Eligible for PUA Weeks 50-20 through 32-21
Ineligible for PUA Weeks 11-20 through 49-20, 33-21

**PROCEDURAL HISTORY:** On May 27, 2021, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was eligible for PUA benefits beginning December 6, 2020. On June 16, 2021, the May 27, 2021 PUA determination became final without claimant having filed a request for hearing. On June 22, 2021, claimant filed a late request for hearing on the May 27, 2021 PUA determination. On June 27, 2022, notice was mailed to claimant that a hearing was scheduled for July 12, 2022 to determine whether claimant filed a timely request for hearing or had good cause to file his request for hearing late and, if so, the merits of the May 27, 2021 PUA determination. On July 12, 2022, ALJ Scott convened a hearing at which claimant failed to appear, and on July 13, 2022 issued Order No. 22-UI-198124, dismissing claimant's request for hearing due to his failure to appear.

On July 15, 2022, claimant filed a timely request to reopen the July 12, 2022 hearing. On May 23, 2023 and continuing on June 27, 2023, ALJ Monroe conducted a hearing, and on July 6, 2023 issued Order No. 23-UI-229652, allowing claimant's request to reopen the July 12, 2022 hearing, cancelling Order No. 22-UI-198124, concluding that claimant's request for hearing was timely, and modifying the May 27, 2021 PUA determination by concluding that claimant was eligible for PUA benefits for the weeks of December 6, 2020 through August 14, 2021 (weeks 50-20 through 32-21), but was ineligible to receive PUA benefits for the weeks of March 8, 2020 through December 5, 2020 (weeks 11-20 through 49-20) and August 15, 2021 through August 21, 2021 (week 33-21). On July 17, 2023, claimant filed an application for review of Order No. 23-UI-229652 with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** Claimant submitted several written arguments including July 17, July 19, July 20, July 24, and July 25, 2023. Claimant submitted multiple written arguments on July 17 and July 24, 2023. Claimant's arguments contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented him from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13,

2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's arguments to the extent they were based on the record.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 23-UI-229652 is affirmed.
