

**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-0785**

*Affirmed*  
*Disqualification*

**PROCEDURAL HISTORY:** On May 18, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct and that claimant was therefore disqualified from receiving unemployment insurance benefits effective April 16, 2023 (decision # 75444). Claimant filed a timely request for hearing. On July 5, 2023, ALJ Fraser conducted a hearing and issued Order No. 23-UI-229541, affirming decision # 75444. On July 17, 2023, claimant filed an application for review with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** On July 17, 2023, August 15, 2023, and August 17, 2023, claimant submitted written arguments to EAB. Claimant did not declare that he provided a copy of any of his arguments to the opposing party as required by OAR 471-041-0080(2)(a) (May 13, 2019). The arguments also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented him from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019).

The employer submitted written argument to EAB. The employer's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond the employer's reasonable control prevented them from offering the information during the hearing.

Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 23-UI-229541 is affirmed.
