## EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0787

Affirmed Eligible Weeks 10-23 and 13-23 Ineligible Weeks 09-23, 11-23 and 12-23

**PROCEDURAL HISTORY:** On March 15, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and was ineligible for benefits for the week of February 26 through March 4, 2023 (week 13-23) and until the reason for the denial had ended. On March 28, 2023, the Department served notice of an administrative decision concluding that claimant failed to provide information in accordance with the Department's rules and was ineligible for benefits from March 12 through 25, 2023 (weeks 11-23 through 12-23) and until the reason for the denial had ended (decision # 91936). On March 29, 2023, claimant filed timely requests for hearing on the March 15, 2023 administrative decision and decision # 91936. On June 27, 2023, ALJ Roberts conducted a consolidated hearing on both administrative decisions. On July 5, 2023 ALJ Roberts issued Order No. 23-UI-229484, modifying the March 15, 2023 administrative decision by concluding that claimant was not eligible for benefits for the week of February 26 through March 4, 2023 (week 09-23), but was eligible for benefits from March 5 through 25, 2023 (weeks 10-23 through 12-23). Also on July 5, 2023, ALJ Roberts issued Order No. 23-UI-229445, modifying decision # 91936 by concluding that claimant was not eligible for benefits from March 12 through 25, 2023 (weeks 11-23 through 12-23), but was eligible for benefits for the week of March 26 through April 1, 2023 (week 13-23). On July 17, 2023, claimant filed applications on Orders No. 23-UI-229484 and 23-UI-229445.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-229484 and 23-UI-229445. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-0788 and 2023-EAB-0787).

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**. To summarize, the collective effect of the orders under review that are hereby adopted is that claimant is eligible for benefits for weeks 10-23 and 13-23. Claimant is not eligible for benefits for weeks 09-23, 11-23, and 12-23.

**DECISION:** Orders No. 23-UI-229484 and 23-UI-229445 are affirmed.
