

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0789

Application for Review Dismissed
No Justiciable Controversy

PROCEDURAL HISTORY: On April 25, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to provide information in accordance with the Department’s rules and was therefore ineligible to receive unemployment insurance benefits for the weeks including April 3, 2022 through April 16, 2022 (weeks 14-22 through 15-22) and until the reason for the denial had ended (decision # 125044). On May 16, 2022, decision # 125044 became final without claimant having filed a request for hearing. On May 3, 2023, claimant filed a late request for hearing on decision # 125044. On June 8, 2023, notice was mailed to claimant that a hearing was scheduled for June 21, 2023 to determine if claimant had good cause to file her late request for hearing and, if so, the merits of decision # 125044. On June 21, 2023, ALJ Sachet-Rung conducted a hearing at which the Department submitted an Attestation in lieu of attending, the hearing and on June 28, 2023 issued Order No. 23-UI-228930, allowing claimant’s late request for hearing and reversing decision # 125044 by concluding that claimant did not fail to provide information in accordance with the Department’s rules and was therefore eligible to receive benefits for the weeks of April 3, 2022 through April 16, 2022 (weeks 14-22 through 15-22). On July 3, 2023, claimant filed an application for review with the Employment Appeals Board (EAB).

CONCLUSIONS AND REASONS: Claimant’s application for review of Order No. 23-UI-228930 presents no justiciable controversy and is dismissed.

On July 3, 2023, claimant filed with EAB an application for review of Order No. 23-UI-228930, which allowed the appellant benefits for all the weeks at issue.¹ Claimant did not assign error to any portion of Order No. 23-UI-228930, did not request reversal of any portion of Order No. 23-UI-228930, and alleged no facts entitling her to further relief in this matter. Accordingly, there is no justiciable

¹ The “Conclusions of Law” portion of the order under review stated, “Claimant failed to furnish information by the deadline[.]” Order No. 23-UI-228930 at 2. However, the rest of the order found that the deadline to furnish the information was April 18, 2022 and claimant had furnished it April 13, 2022, and the order concluded that claimant was eligible for benefits based upon having timely furnished the requested information. Order No. 23-UI-228930 at 2, 5. Therefore, this “Conclusions of Law” portion of the order is presumed to be a scrivener’s error.

controversy before EAB based upon claimant's application for review of Order No. 23-UI-228930. *See accord Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995). Because this case before EAB presents no justiciable controversy, the application for review of Order No. 23-UI-228930 is dismissed and the order remains undisturbed.

DECISION: The application for review filed July 3, 2023 is dismissed. Order No. 23-UI-228930 remains undisturbed.
