

**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-0805**

*Affirmed*  
*Ineligible Weeks 17-23 through 18-23*

**PROCEDURAL HISTORY:** On May 10, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision that claimant failed to register for work in accordance with the Department's rules and was not eligible for benefits for the week of April 23 through 29, 2023 and until the reason for the denial ended. Claimant filed a timely request for hearing. On June 26, 2023, ALJ Lucas conducted a hearing, and on June 30, 2023 issued Order No. 23-UI-229245, modifying the May 10, 2023 administrative decision by concluding claimant was not eligible for benefits from April 23 through May 6, 2023. On July 20, 2023, claimant filed an application for review with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's argument to the extent it was based on the record.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 23-UI-229245 is affirmed.
