# EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0810

Reversed & Remanded

**PROCEDURAL HISTORY AND FINDINGS OF FACT:** On January 31, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged for misconduct and was therefore disqualified from receiving unemployment insurance benefits effective December 25, 2022 (decision # 105230). On February 21, 2023, decision # 105230 became final without claimant having filed a request for hearing. On March 7, 2023, claimant filed a late request for hearing on decision # 105230.

ALJ Kangas considered claimant's request, and on June 23, 2023 issued Order No. 23-UI-228578, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by July 7, 2023. On July 10, 2023, claimant filed a late response to the appellant questionnaire<sup>1</sup> and a timely application for review of Order No. 23-UI-228578 with the Employment Appeals Board (EAB). On July 27, 2023, ALJ Kangas mailed a letter stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue another order regarding this matter because the questionnaire response was late. This matter comes before EAB based upon claimant's July 10, 2023 application for review of Order No. 23-UI-228578.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's response to the appellant questionnaire, marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**CONCLUSIONS AND REASONS:** Order No. 23-UI-228578 is set aside and this matter remanded for a hearing on whether claimant's late request for hearing on decision # 105230 should be allowed and, if so, the merits of that decision.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

The request for hearing on decision # 105230 was due by February 21, 2023. Because claimant did not file their request for hearing until March 7, 2023, the request was late. On their appellant questionnaire response, claimant suggested that they filed a timely request for hearing, stating that they "called and talked to someone weekly." EAB Exhibit 1 at 2. The Department's records appear to support this assertion. A comment entered into the Department's claim system, dated February 7, 2023, stated, "PTC clmnt called to check status of claim, advised of deny decision, suvbmitted [*sic*] a hearting [*sic*] request for clmnt, advised to keep claiming each week until hearing, clmnt understands". Similarly, a comment entered into the Department's claim system on February 17, 2023 stated, in relevant part, ". . . forwarded hearing request, advsd to continue to claiming [*sic*] and provided timeline for hearing info and phone # for OAH[.]"<sup>2</sup> These comments suggest that claimant did file one or more timely requests for hearing on decision # 105230. On remand, the ALJ should inquire as to the specific dates on which claimant filed hearing requests, other than the late request for hearing filed on March 7, 2023, and confirm that such requests related to decision # 105230. The Department may wish to provide a witness for this hearing, rather than submitting an attestation in lieu of attendance.

Order No. 23-UI-228578 therefore is reversed, and this matter remanded for a hearing on whether claimant filed a timely request for hearing and, if so, the merits of decision # 105230.

**DECISION:** Order No. 23-UI-228578 is set aside, and this matter remanded for further proceedings consistent with this order.
