

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0815

Affirmed
Ineligible for Benefits Weeks 19-23 through 20-23

PROCEDURAL HISTORY: On May 23, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to provide information as required by the Department's rules and was not eligible for benefits for the weeks from May 7 through 20, 2023 and until the reason for the denial ended (decision # 131238). On May 24, 2023, the Department served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and was not eligible for benefits for the week of May 7 through 13, 2023 and until the reason for the denial ended. Claimant filed timely requests for hearing. On June 27, 2023, ALJ Nyberg conducted hearings, and on July 5, 2023 issued Order No. 23-UI-229503 affirming decision # 131238, and Order No. 23-UI-229464 modifying the May 24, 2023 administrative order by concluding that claimant was not eligible for benefits for the weeks from May 7 through May 20, 2023. On July 24, 2023, claimant filed applications for review with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Order Nos. 23-UI-229503 and 23-UI-229464. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-0815 and 2023-EAB-0814).

EAB reviewed both hearing records. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Order Nos. 23-UI-229503 and 23-UI-229464 are affirmed.
