

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0819

Affirmed
Ineligible Weeks 20-23 through 22-23

PROCEDURAL HISTORY: On May 31, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to provide information to the Department as required and was not eligible for benefits for the week of May 14 through 20, 2023 and until the reason for the denial ended (decision # 114629). On June 1, 2023, the Department served notice of an administrative decision concluding that claimant had failed to register for work in accordance with the Department's rules and was ineligible for benefits for the week of May 14 through 20, 2023 and until the reason for the denial ended. Claimant filed timely requests for hearing. On July 17, 2023, ALJ Lewis conducted a hearing and issued Order Nos. 23-UI-230615 and 23-UI-230616, modifying decision # 114629 and the June 1, 2023 administrative decision by concluding claimant was not eligible for benefits from May 14 through June 3, 2023.

On July 25, 2023, claimant filed applications for review with the Employment Appeals Board (EAB). Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-230615 and 23-UI-230616. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-0820 and 2023-EAB-0819).

EAB reviewed the entire hearing record and claimant's written argument to the extent it was based on the hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Order Nos. 23-UI-230615 and 23-UI-230616 are affirmed.
