

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0822

Application for Review Dismissed

PROCEDURAL HISTORY: On June 2, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was therefore disqualified from receiving unemployment insurance benefits effective May 7, 2023 (decision # 143435). Claimant filed a timely request for hearing. On July 11, 2023, ALJ Enyinnaya conducted a hearing, and on July 20, 2023 issued Order No. 23-UI-230915, reversing decision # 143435 by concluding that claimant voluntarily quit work with good cause and was not disqualified from receiving benefits. On July 26, 2023, the employer filed an application for review with the Employment Appeals Board (EAB).

FINDING OF FACT: (1) On August 1, 2023, the employer faxed a letter to EAB asking to withdraw their application for review of Order No. 23-UI-230915.

CONCLUSIONS AND REASONS: The employer's application for review is dismissed.

OAR 471-041-0098 (October 29, 2006) provides that an applicant's written request to withdraw an application for review will be allowed unless the request is received after EAB's decision has been issued.

On August 1, 2023, EAB received a written request, by fax, in which the employer withdrew the application for review of Order No. 23-UI-230915. EAB had not yet issued a decision. Under OAR 471-041-0098, the employer's request to withdraw the application for review is allowed.

DECISION: The application for review filed July 26, 2023 is dismissed. Order No. 23-UI-230915 remains undisturbed.
