

**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-0855**

*Affirmed*  
*Ineligible Weeks 22-23 through 23-23*

**PROCEDURAL HISTORY:** On June 14, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and was therefore ineligible to receive unemployment insurance benefits for the week of May 28, 2023 through June 3, 2023 (week 22-23) and until the reason for the denial had ended. Claimant filed a timely request for hearing. On July 20, 2023, ALJ Lucas conducted a hearing. The Employment Department submitted an Attestation in lieu of attending the hearing. On July 21, 2023, ALJ Lucas issued Order No. 23-UI-231092, modifying the June 14, 2023 administrative decision by concluding that claimant failed to register for work in accordance with the Department's rules and was therefore ineligible to receive benefits for the weeks including May 28, 2023 through June 10, 2023 (weeks 22-23 through 23-23).<sup>1</sup> On August 3, 2023, claimant filed an application for review with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** EAB considered claimant's written argument in reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 23-UI-231092 is affirmed.
