

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0856

Affirmed ~ Late Request for Hearing Dismissed
Confirmada ~ La Aplicación Tardía Para Una Audiencia Es Rechazada

PROCEDURAL HISTORY AND FINDINGS OF FACT: On February 8, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was therefore disqualified from receiving unemployment insurance benefits effective June 28, 2020 (decision # 94334). On February 28, 2022, decision # 94334 became final without claimant having filed a request for hearing. On February 1, 2023, claimant filed a late request for hearing on decision # 94334. ALJ Kangas considered claimant's request, and on June 9, 2023 issued Order No. 23-UI-227377, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by June 23, 2023. Claimant did not file a response to the appellant questionnaire. On June 26, 2023, claimant filed a timely application for review of Order No. 23-UI-227377 with the Employment Appeals Board (EAB).

HISTORIA PROCESAL Y DETERMINACIONES DE HECHO: El 8 de febrero de 2022, el Departamento de Empleo de Oregon (el Departamento) envió notificación de una decisión administrativa concluyendo que la reclamante dejó el trabajo sin una buena causa y fue descalificada de recibir beneficios de desempleo a partir del 28 de junio de 2020 (decisión # 94334). Decisión # 94334 se convirtió en final el 28 de febrero de 2022 sin que la reclamante hubiera presentado una aplicación para una audiencia. El primer de febrero de 2023, la reclamante presentó una aplicación tardía para una audiencia sobre decisión # 94334. La Jueza Administrativa Kangas revisó la aplicación tardía de la reclamante y el 9 de junio de 2023, emitió la Orden No. 23-UI-227377, rechazando la aplicación de la reclamante porque la aplicación era tarde. La orden también dió a la reclamante la oportunidad de responder a un cuestionario antes del 23 de junio de 2023 sobre por qué la reclamante presentó su aplicación tarde. La reclamante no presentó una respuesta al cuestionario. El 26 de junio de 2023, la reclamante presentó una aplicación oportuna de revisión de la Orden No. 23-UI-227377 a La Junta de Apelaciones de Empleo (EAB).

CONCLUSIONS AND REASONS: Claimant's late request for hearing is dismissed. *La aplicación tardía para una audiencia de la reclamante es rechazada.*

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

The deadline to request a hearing on decision # 94334 was February 28, 2022. Because claimant filed their request for hearing on February 1, 2023, the request for hearing was late. Claimant was given the opportunity to respond to an appellant questionnaire in order to explain the circumstances that caused the request for hearing to be filed late. However, claimant did not respond to the appellant questionnaire, and the record therefore contains no details as to why the request for hearing was filed late. Accordingly, claimant has not established good cause for the late filing, and the late request for hearing is dismissed.

DECISION: Order No. 23-UI-227377 is affirmed. *La Orden de la Audiencia 23-UI-227377 queda confirmada.*
