EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0870

Reversed & Remanded

PROCEDURAL HISTORY AND FINDINGS OF FACT: On March 17, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not able, available, or actively seeking work during the weeks including February 26, 2023 through March 11, 2023 (weeks 09-23 through 10-23) and therefore was ineligible to receive unemployment insurance benefits for those weeks and until the reason for the denial had ended (decision # 64838). Also on March 17, 2023, the Department served notice of an administrative decision concluding that claimant failed to provide information in accordance with the Department's rules during the week of February 26, 2023 through March 4, 2023 (week 09-23) and was therefore ineligible to receive benefits during that week (decision # 70553). On April 6, 2023, decisions # 64838 and 70553 became final without claimant having filed a request for hearing. On April 14, 2023, claimant filed a late request for hearings on decisions # 64838 and 70553. ALJ Kangas of the Office of Administrative Hearings (OAH) considered claimant's request, and on August 3, 2023 issued Order Nos. 23-UI-232236 and 23-UI-232237, dismissing claimant's request for hearings as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by August 17, 2023. Claimant did not file a response to the appellant questionnaire. On August 8, 2023, claimant filed a timely application for review of Order Nos. 23-UI-232236 and 23-UI-232237 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Order Nos. 23-UI-232236 and 23-UI-232237. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-0870 and 2023-EAB-0871).

CONCLUSIONS AND REASONS: Order Nos. 23-UI-232236 and 23-UI-232237 are reversed and the matters remanded for further proceedings at OAH.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

The deadline to request a hearing on decisions # 64838 and 70553 was April 6, 2023. Because claimant filed their request for hearings on April 14, 2023, the request for hearings was late. Order Nos. 23-UI-232236 and 23-UI-232237 gave claimant the opportunity to respond to an appellant questionnaire in order to explain the circumstances that caused the request for hearing to be filed late. However, claimant did not respond to the appellant questionnaire. Because claimant filed their applications for review of Order Nos. 23-UI-232236 and 23-UI-232237 with EAB prior to the deadline to file an appellant questionnaire response with OAH, this matter is remanded to OAH to determine whether claimant had good cause to file the late request for hearings and, if so, to conduct a hearing on the merits of decisions # 64838 and 70553.

DECISION: Order Nos. 23-UI-232236 and 23-UI-232237 are set aside, and these matters are remanded for further proceedings consistent with this order.
