

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0878

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On February 16, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not able to work during the weeks of April 19, 2020 through October 3, 2020 (weeks 17-20 through 40-20) and therefore was not eligible to receive unemployment insurance benefits for those weeks and until the reason for the denial ended (decision # 125823). On March 8, 2021, decision # 125823 became final without claimant having filed a request for hearing. On February 18, 2022, claimant filed a late request for hearing on decision # 125823. ALJ Kangas considered claimant's request, and on May 23, 2022 issued Order No. 22-UI-194288, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by June 6, 2022. On May 31, 2022, claimant filed a timely response to the appellant questionnaire. On August 24, 2022, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 22-UI-194288 was vacated and that a new hearing would be scheduled to determine whether claimant had good cause to file the late request for hearing and, if so, the merits of decision # 125823. On July 18, 2023, ALJ Blam conducted a hearing, and on July 26, 2023 issued Order No. 23-UI-231478, dismissing claimant's late request for hearing on decision # 125823 and leaving that decision undisturbed. On August 8, 2023, claimant filed an application for review of Order No. 23-UI-231478 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's argument to the extent it was based on the record.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-231478 is affirmed.
