

**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-0884**

*Late Application for Review Dismissed*

**PROCEDURAL HISTORY:** On December 1, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits beginning April 26, 2020 because claimant quit working for the employer without good cause (decision # 125627). On December 21, 2020, decision # 125627 became final without claimant having filed a request for hearing. On December 27, 2021, claimant filed a late request for hearing. On February 21, 2023, ALJ Goodrich issued Order No 23-UI-216705, dismissing claimant's request for hearing based on a finding that claimant had withdrawn the request, leaving decision # 125627 undisturbed. On March 13, 2023, Order No. 23-UI-216705 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On August 12, 2023, claimant filed a late application for review with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement included with claimant's application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**FINDING OF FACT:** (1) Order No. 23-UI-216705, mailed to claimant on February 21, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-216705 at 1. Order No. 23-UI-216705 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before March 13, 2023 to be timely."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 23-UI-216705 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR

471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-216705 was due March 13, 2023. Because claimant did not file their application for review until August 12, 2023, the application for review was late. Claimant provided a written statement with the application for review. However, claimant’s written statement did not describe the circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant’s late application for review is dismissed.

**DECISION:** The application for review filed August 12, 2023 is dismissed. Order No. 23-UI-216705 remains undisturbed.
