<p><b>EMPLOYMENT APPEALS BOARD DECISION</b> <b>2023-EAB-0892</b></p>
--

*Affirmed*  
*Ineligible Weeks 20-23 through 22-23*

**PROCEDURAL HISTORY:** On June 1, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits for the weeks from May 14 through May 27, 2023 and until claimant provided ID verification documentation following the rules set by the Department (decision # 112235). On June 2, 2023, the Department served notice of an administrative decision concluding that claimant was denied benefits for the week of May 14 through May 20, 2023 and until claimant registered for work following the rules set by the Department. Claimant filed a timely request for hearing on both administrative decisions. On July 18, 2023, ALJ Taylor conducted a hearing, and on July 24, 2023 issued Orders No. 23-UI-231259 and 23-UI-231258, modifying decision # 112235 and the June 2, 2023 administrative decision by concluding that claimant was not eligible for benefits for the weeks from May 14 through June 3, 2023 (weeks 20-23 through 22-23). On August 9, 2023, claimant filed an application for review of Orders No. 23-UI-231259 and 23-UI-231258 with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENT:** Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-231259 and 23-UI-231258. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-0891 and 2023-EAB-0892).

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 23-UI-231259 and 23-UI-231258 are affirmed.
