EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0895

Late Application for Review Dismissed

PROCEDURAL HISTORY: On June 8, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective May 7, 2023 (decision # 150351). Claimant filed a timely request for hearing. On July 19, 2023, ALJ Logan conducted a hearing, and on July 20, 2023 issued Order No. 23-UI-231049, affirming decision # 150351. On August 9, 2023, Order No. 23-UI-231049 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On August 10, 2023, claimant filed a late application for review with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is a copy of claimant's application for review and the envelope in which it was mailed to EAB, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

FINDING OF FACT: (1) Order No. 23-UI-231049, mailed to claimant on July 20, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-231049 at 6. Order No. 23-UI-231049 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before August 9, 2023 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 23-UI-231049 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or

circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-231049 was due August 9, 2023. The filing date for an application for review filed by mail is the postmark date affixed to the envelope in which the application was mailed. OAR 471-041-0065(1)(b) (May 13, 2019). The postmark date on the envelope in which claimant mailed their application for review was August 10, 2023, which therefore is the filing date. EAB Exhibit 1 at 2. Because claimant did not file their application for review until August 10, 2023, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented claimant from filing the application for review by the August 10, 2023 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed August 10, 2023 is dismissed. Order No. 23-UI-231049 remains undisturbed.
