EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0896

Reversed & Remanded

PROCEDURAL HISTORY AND FINDINGS OF FACT: On March 29, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to complete a Quality Control Questionnaire and therefore was ineligible to receive unemployment insurance benefits for the week of March 19, 2023 through March 25, 2023 (week 12-23), and until the reason for the denial had ended (decision # 123956). On April 18, 2023, decision # 123956 became final without claimant having filed a request for hearing. On April 20, 2023, claimant filed a late request for hearing.

ALJ Kangas considered claimant's request, and on August 1, 2023 issued Order No. 23-UI-232048, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by August 15, 2023. On August 10, 2023, claimant filed a timely response to the appellant questionnaire and a timely application for review of Order No. 23-UI-232048 with the Employment Appeals Board (EAB). This matter comes before EAB based upon claimant's August 10, 2023 application for review of Order No. 23-UI-232048.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's response to the appellant questionnaire, marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

CONCLUSIONS AND REASONS: Order No. 23-UI-232048 is set aside and this matter remanded for a hearing on whether claimant's late request for hearing on decision # 123956 should be allowed and, if so, the merits of that decision.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010

(February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

The deadline to file a request for hearing on decision # 123956 was April 18, 2023. Because claimant did not file a request for hearing on decision # 123956 until April 20, 2023, the request for hearing was late.

In claimant's appellant questionnaire response, claimant stated that they did not receive decision # 123956, and filed a request for hearing on the decision with the assistance of a Department representative on April 18, 2023. EAB Exhibit 1 at 1, 2. Claimant further stated that the circumstances that led them to do so were that they "called for 5 weeks trying to figure out what was going with my unemployment. All I was being told is that they could not get a hold of the woman who handled these things. I called every week. It wasn't until another gentleman I talked to mentioned filing an appeal for back pay & that he would file it. The next woman I spoke to said she did not see an appeal on file and she filed it again herself just in case." EAB Exhibit 1 at 2.

If claimant did not receive decision # 123956 they may have experienced a factor beyond their control that prevented them from filing their request for hearing on time. Further, if, as claimant asserts, claimant actually filed their request for hearing on April 18, 2023, claimant's appeal would have been timely. However, remand is required to develop the record as to whether claimant filed a timely request for hearing, or, if the request was filed late, whether claimant had good cause to extend the deadline a reasonable time. On remand, the ALJ should clarify when precisely claimant filed their request for hearing, and if it was filed after April 18, 2023, whether factors beyond claimant's control or an excusable mistake prevented a timely filing. If claimant filed their request for hearing late but was prevented from doing so in a timely fashion by a circumstance beyond their control or an excusable mistake, the ALJ should also ask questions to develop whether claimant's filing date occurred within a seven-day "reasonable time" of when any such factors ceased to exist.

Order No. 23-UI-232048 therefore is reversed, and this matter remanded for a hearing on whether claimant's late request for hearing should be allowed and, if so, the merits of decision # 123956.

DECISION: Order No. 23-UI-232048 is set aside, and this matter remanded for further proceedings consistent with this order.
