

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0910

Affirmed
No Disqualification

PROCEDURAL HISTORY: On February 21, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving benefits effective December 11, 2023 (decision # 110302). Claimant filed a timely request for hearing. On July 13 and August 2, 2023, ALJ Scott conducted a hearing, and on August 8, 2023 issued Order No. 23-UI-232611, reversing decision # 110302 by concluding that claimant was discharged, but not for misconduct, and was not disqualified from receiving benefits based on the work separation. On August 14, 2023, the employer filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: The employer's argument contained information that was not part of the hearing record and requested to provide other additional information, but did not show that factors or circumstances beyond the employer's reasonable control prevented them from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-232611 is affirmed.
