

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0924

Affirmed
Overpayment Assessed

PROCEDURAL HISTORY: On July 1, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received \$3,256 in regular unemployment insurance (regular UI) and \$1,800 in Federal Pandemic Unemployment Compensation (FPUC) benefits to which claimant was not entitled and must repay (decision # 162248). Claimant filed a timely request for hearing. On July 20, 2023, ALJ Frank conducted a hearing, and on July 27, 2023 issued Order No. 23-UI-231726, affirming decision 162248. On August 16, 2023, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered claimant's written argument when reaching this decision. Claimant asserted in his written argument that he was not overpaid regular UI and FPUC benefits because he was actively seeking work during the weeks he claimed and should not have been denied benefits. However, the October 15, 2021 administrative decision that denied claimant benefits and concluded that claimant did not actively seek work during weeks 30-21 through 35-21 is final and binding as a matter of law, and is not under review.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-231726 is affirmed.
