Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On May 3, 2011, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant willfully underreported earnings to obtain \$17,763 in benefits that he must repay, assessing a \$2,664.45 monetary penalty, and disqualifying claimant from 52 weeks of future benefits. On May 23, 2011, the May 3, 2011 administrative decision became final without claimant having filed a request for hearing. On January 20, 2022, claimant filed a late request for hearing. ALJ Kangas reviewed claimant's request, and on May 3, 2022 issued Order No. 22-UI-192784, dismissing the request as late, subject to claimant's right to renew the request by filing a response to an appellant questionnaire by May 17, 2022.

On May 10, 2022, claimant filed a timely response to the appellant questionnaire. On June 12, 2023, the Office of Administrative Hearings (OAH) mailed claimant a letter stating that based on claimant's response to the appellant questionnaire, Order No. 22-UI-192784 was cancelled and vacated, and that a hearing would be scheduled to determine whether to allow claimant's late request for hearing and, if so, the merits of the May 3, 2011 administrative decision. On July 25, 2023, ALJ Goodrich conducted the hearing, and on August 2, 2023 issued Order No. 23-UI-232130, dismissing claimant's late request for hearing, leaving the May 3, 2011 administrative decision undisturbed. On August 16, 2023, claimant filed an application for review of Order No. 23-UI-232130 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-232130 is affirmed.
