

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0953

Affirmed
No Disqualification

PROCEDURAL HISTORY: On May 4, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged for misconduct and disqualified from receiving unemployment insurance benefits effective January 22, 2023 (decision # 170402). Claimant filed a timely request for hearing. On August 10, 2023, ALJ Scott conducted a hearing, at which the employer initially appeared, but chose not to participate in the hearing or request to postpone the hearing. On August 11, 2023, ALJ Scott issued Order No. 23-UI-232991, reversing decision # 170402 by concluding that the employer discharged claimant, not for misconduct, and that claimant was not disqualified from receiving benefits based on the work separation. On August 23, 2023, the employer filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: The employer did not declare that they provided a copy of their argument to the opposing party as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond the employer's reasonable control prevented them from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-232991 is affirmed.
