Ineligible Weeks 14-23 through 16-23

PROCEDURAL HISTORY: On April 20, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits for the weeks from April 2 through April 15, 2023 because she was not available for work during those weeks (decision # 92337). Claimant filed a timely request for hearing. On May 30, 2023, the Office of Administrative Hearings (OAH) served notice that the hearing was scheduled for June 12, 2023. On June 12, 2023, claimant failed to appear at the hearing, and ALJ Frank issued Order No. 23-UI-227505, dismissing claimant's request for hearing due to her failure to appear. On June 20, 2023, claimant filed a timely request to reopen the hearing. On July 18, 2023, OAH served notice of a hearing scheduled for August 1, 2023 on whether to grant claimant's request to reopen the June 12, 2023 hearing and, if so, the merits of decision # 92337. On August 1, 2023, ALJ S. Lee conducted the hearing, and on August 4, 2023 issued Order No. 23-UI-232481, granting claimant's request to reopen the hearing and modifying decision # 92337 to conclude that claimant was ineligible for benefits for the weeks from April 2 through April 22, 2023 (weeks 14-23 through 16-23). On August 23, 2023, claimant filed an application for review of Order No. 23-UI-232481 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-232481 is affirmed.
