

**EMPLOYMENT APPEALS BOARD DECISION**  
**2023-EAB-0957**

*Affirmed*  
*Late Request for Hearing on decision # 193546 Dismissed*  
*Overpayment Waiver Denied*

**PROCEDURAL HISTORY:** On May 30, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain benefits, and assessing a \$12,459 overpayment of combined federal and state unemployment insurance benefits that claimant was required to repay, a \$3,737.70 monetary penalty, and a 52-week disqualification from future benefits (decision # 193546). On June 20, 2023, decision # 193546 became final without claimant having filed a request for hearing. On June 23, 2023, the Department issued an administrative decision denying claimant's request to waive recovery of the overpayment assessed in decision # 193546 (decision # 80241).

On July 6, 2023, claimant filed a late request for hearing on decision # 193546 and a timely request for hearing on decision # 80241. On August 1, 2023, ALJ Blam conducted hearings regarding both decisions. On August 7, 2023, ALJ Blam issued Order No. 23-UI-232525, dismissing claimant's request for hearing on decision # 193546 as late without good cause. On August 8, 2023, ALJ Blam issued Order No. 23-UI-232676, affirming decision # 80241. On August 23, 2023, claimant filed applications for review of Orders No. 23-UI-232525 and 23-UI-232676 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-232525 and 23-UI-232676. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-0956 and 2023-EAB-0957).

**WRITTEN ARGUMENT:** Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's argument to the extent it was based on the record.

EAB reviewed both hearing records. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 23-UI-232525 and 23-UI-232676 are affirmed.
