

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0973

*Orders No. 23-UI-233824 and 23-UI-233829 Affirmed
Ineligible Weeks 27-23 and 28-23, Eligible Week 29-23*

PROCEDURAL HISTORY: On July 18, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to provide information in accordance with the Department's rules and was ineligible for benefits from July 2 through 15, 2023 (weeks 27-23 and 28-23) and until the reason for the denial ended (decision # 115806). On July 19, 2023, the Department served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and was ineligible for benefits for the week of July 2 through 8, 2023 (week 27-23) and until the reason for the denial ended. Claimant filed timely requests for hearing on decision # 115806 and the July 19, 2023 administrative decision.

On August 18, 2023, ALJ Roberts conducted a hearing on both administrative decisions. On August 21, 2023, ALJ Roberts issued Order No. 23-UI-233824, modifying decision # 115806 by concluding that claimant was not eligible to for benefits for weeks 27-23 and 28-23, but was eligible for benefits for the week of July 16 through 22, 2023 (week 29-23). Also on August 21, 2023, ALJ Roberts issued Order No. 23-UI-233829, modifying the July 19, 2023 administrative decision by concluding that claimant was not eligible for benefits for weeks 27-23 and 28-23, but was eligible for benefits for week 29-23. On August 29, 2023, claimant filed applications for review of Orders No. 23-UI-233824 and 23-UI-233829.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 23-UI-233824 and 23-UI-233829. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2023-EAB-0972 and 2023-EAB-0973). EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

To summarize, the collective effect of the orders under review that are hereby **adopted** is that claimant is ineligible for benefits for weeks 27-23 and 28-23. Claimant is eligible for benefits for week 29-23.

DECISION: Orders No. 23-UI-233824 and 23-UI-233829 are affirmed.
