EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0976

Late Application for Review Dismissed

PROCEDURAL HISTORY: On December 29, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits for the week of December 11 through December 17, 2022 and until claimant registered for work following the Department's rules. Claimant filed a timely request for hearing. On February 6, 2023, the Office of Administrative Hearings (OAH) mailed claimant notice of a hearing scheduled for February 17, 2023. On February 17, 2023, claimant failed to appear at the hearing, and ALJ Chiller issued Order No. 23-UI-216593, dismissing claimant's request for hearing due to his failure to appear. On March 9, 2023, Order No. 23-UI-216593 became final without claimant having filed a request to reopen the hearing. On May 30, 2023, claimant filed a late request to reopen the hearing. ALJ Kangas reviewed the request, and on August 1, 2023 issued Order No. 23-UI-232008, dismissing the request as late without a showing of good cause. On August 21, 2023, Order No. 23-UI-232008 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On August 31, 2023, claimant filed a late application for review with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is a copy of claimant's application for review and included written statement, which has been marked as EAB Exhibit 1 and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

FINDING OF FACT: (1) Order No. 23-UI-232008, mailed to claimant on August 1, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-232008 at 4. Order No. 23-UI-232008 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before August 21, 2023 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 23-UI-232008 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-232008 was due August 21, 2023. Because claimant did not file their application for review until August 31, 2023, the application for review was late. Claimant provided a written statement with the application for review. EAB Exhibit 1. However, claimant's written statement did not describe the circumstances that prevented claimant from filing the application for review on time. EAB Exhibit 1. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed August 31, 2023 is dismissed. Order No. 23-UI-232008 remains undisturbed.
