

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-0979

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On February 2, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and was ineligible for benefits for the week of January 15 through 21, 2023 (week 03-23) and until the reason for the denial ended. On February 22, 2023, the February 2, 2023 administrative decision became final without claimant having filed a request for hearing. On March 6, 2023, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on April 17, 2023 issued Order No. 23-UI-222267, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by May 1, 2023. On May 5, 2023, claimant filed a late response to the appellant questionnaire and a timely application for review of Order No. 23-UI-222267 with the Employment Appeals Board (EAB). On August 30, 2023, ALJ Kangas mailed a letter to claimant stating that because the appellant questionnaire response was late, it would not be considered and a new order would not be issued. This matter comes before EAB based upon claimant's May 5, 2023 application for review of Order No. 23-UI-222267.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's response to the appellant questionnaire, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDINGS OF FACT: (1) On February 2, 2022, the February 2, 2022 administrative decision was mailed to claimant's address of record on file with the Department. The decision stated, "You have the right to appeal this decision if you do not believe it is correct. Your request for appeal must be received no later than 02/22/2023." Exhibit 1 at 1. Claimant received the decision on or about February 11, 2023.

(2) On March 6, 2023, claimant filed their request for hearing.

CONCLUSIONS AND REASONS: Claimant’s late request for hearing is dismissed.

ORS 657.269 provides that the Department’s decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a “reasonable time” upon a showing of “good cause.” OAR 471-040-0010 (February 10, 2012) provides that “good cause” includes factors beyond an applicant’s reasonable control or an excusable mistake, and defines “reasonable time” as seven days after those factors ceased to exist.

The deadline to file a timely request for hearing on the February 2, 2023 administrative decision was February 22, 2023. Claimant filed their request for hearing on March 6, 2023. The request for hearing therefore was late. Claimant stated in their appellant questionnaire response that, “In February I got a denial letter because I didn’t complete Work Source requirements. I had no idea that I needed to do that. I made an appointment for two weeks later[.]” EAB Exhibit 1 at 3. Claimant’s work search record, submitted as part of their appellant questionnaire response, indicated that they attended that Work Source appointment on February 25, 2023. EAB Exhibit 1 at 7. Accordingly, the record shows that claimant likely received the February 2, 2023 administrative decision on or about February 11, 2023, which was two weeks prior to February 25, 2023. As such, claimant likely had notice of the February 2, 2023 administrative decision and their appeal rights before the deadline to file a request for hearing.

In their appellant questionnaire response, claimant asserted that they filed an appeal “the week of January 16th[.]” EAB Exhibit 1 at 2. As the February 2, 2023 administrative decision had not yet been issued in January 2023, claimant could not have attempted to request a hearing on it. Claimant’s response does not suggest that claimant attempted to file a request for hearing at any time after February 2, 2023 and before the late request for hearing was filed on March 6, 2023. Claimant has not asserted that any factor beyond their reasonable control or an excusable mistake prevented them from filing their request for hearing on time. Claimant therefore has not established good cause for filing the request for hearing late, and the late request for hearing is dismissed.

DECISION: Order No. 23-UI-222267 is affirmed.
