# EMPLOYMENT APPEALS BOARD DECISION 2023-EAB-0999

#### Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On July 7, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was therefore disqualified from receiving unemployment insurance benefits effective April 9, 2023 (decision # 142214). Claimant filed a timely request for hearing. On August 7, 2023, ALJ Lucas conducted a hearing, and on August 11, 2023 issued Order No. 23-UI-232981, affirming decision # 142214. On August 31, 2023, Order No. 23-UI-232981 became final without claimant having filed an application for review of Order No. 23-UI-232981 with the Employment Appeals Board (EAB). On September 1, 2023, claimant filed a late application for review of Order No. 23-UI-232981 with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement included with claimant's late application for review, marked as EAB Exhibit 1, and claimant's application for review showing the time claimant submitted the application, marked as EAB Exhibit 2. Copies are provided to the parties with this decision. Any party that objects to our admitting EAB Exhibits 1 or 2 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibits will remain in the record.

**FINDINGS OF FACT:** (1) Order No. 23-UI-232981, mailed to claimant on August 11, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-232981 at 3. Order No. 23-UI-232981 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before August 31, 2023 to be timely."

(2) Claimant filed their application for review of Order No. 23-UI-232981 by an EAB electronic form submission. The encoded date on the electronic form on which claimant submitted the application for review is September 1, 2023.

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 23-UI-232981 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3). OAR 471-041-0065(1)(e) (May 13, 2019) provides that when an application for review is filed by "electronic means, the filing date is the encoded date on the electronic document."

The application for review of Order No. 23-UI-232981 was due by August 31, 2023. Because claimant did not file their application for review until September 1, 2023, the application for review was late. EAB Exhibit 2. Claimant provided a written statement with the application for review. *See* EAB Exhibit 1. However, claimant's written statement did not describe circumstances preventing them from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed September 1, 2023 is dismissed. Order No. 23-UI-232981 remains undisturbed.
