

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-1002

Late Application for Review Dismissed

PROCEDURAL HISTORY: On February 28, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective February 27, 2022 (decision # 112143). On March 20, 2023, decision # 112143 became final without claimant having filed a request for hearing. On March 23, 2023, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on August 11, 2023 issued Order No. 23-UI-232959, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by August 25, 2023. On August 31, 2023, Order No. 23-UI-232959 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On September 2, 2023, claimant filed a late response to the appellant questionnaire and a late application for review with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's response to the appellant questionnaire, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 23-UI-232959, mailed to claimant on August 11, 2023, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 23-UI-232959 at 2. Order No. 23-UI-232959 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than August 31, 2023."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 23-UI-232959 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 23-UI-232959 was due by August 31, 2023. Because claimant did not file their application for review until September 2, 2023, the application for review was late. Claimant’s application for review did not include a written statement describing the circumstances that prevented claimant from filing the application for review by the August 31, 2023 deadline. Claimant did submit a late response to the appellant questionnaire with their later application for review. *See* EAB Exhibit 1. However, the appellant questionnaire response did not address why the application for review was late. The appellant questionnaire response addresses why the claimant filed a late request for hearing decision # 112143. Accordingly, claimant did not show good cause for the late application for review, and claimant’s late application for review is dismissed.

DECISION: The application for review filed September 2, 2023 is dismissed. Order No. 23-UI-232959 remains undisturbed.
