

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-1007

Affirmed
Disqualification

PROCEDURAL HISTORY: On May 5, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective April 9, 2023 (decision # 111524). Claimant filed a timely request for hearing. On June 23, 2023, ALJ McGorin conducted a hearing and issued Order No. 23-UI-228523, affirming decision # 111524. On June 27, 2023, claimant filed an application for review of Order No. 23-UI-228523 with the Employment Appeals Board (EAB). On August 4, 2023, EAB issued EAB Decision 2023-EAB-0715, setting aside Order No. 23-UI-228523 and remanding the matter to the Office of Administrative Hearings (OAH) for further development of the record. On August 14, 2023, OAH served notice of a hearing scheduled for August 28, 2023. On August 28, 2023, ALJ McGorin convened a hearing at which both claimant and the employer failed to appear. On August 30, 2023, ALJ McGorin issued Order No. 23-UI-234680, affirming decision # 111524. On September 5, 2023, claimant filed an application for review of Order No. 23-UI-234680 with EAB.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-234680 is affirmed.
