

EMPLOYMENT APPEALS BOARD DECISION
2023-EAB-1012

Affirmed
Request to Reopen Denied

PROCEDURAL HISTORY: On April 12, 2023, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was denied benefits for the week of March 26 through April 1, 2023 and until claimant registered for work following the rules set by the Department. Claimant filed a timely request for hearing. On May 23, 2023, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for June 6, 2023. On June 6, 2023, claimant failed to appear at the hearing, and ALJ Chiller issued Order No. 23-UI-227005, dismissing claimant's request for hearing for failure to appear. On June 12, 2023, claimant filed a timely request to reopen the hearing. ALJ Kangas considered claimant's request, and on August 22, 2023 issued Order No. 23-UI-233910, denying the request, leaving Order No. 23-UI-227005 undisturbed. On September 6, 2023, claimant filed an application for review of Order No. 23-UI-233910 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information into the record with their June 12, 2023 request to reopen the June 6, 2023 hearing, as required under OAR 471-040-0040(3) (February 10, 2012). Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into the hearing record when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 23-UI-233910 is affirmed.
